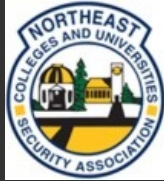

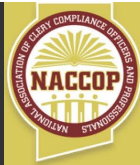

to offer a 1-Day Clery Act Compliance Class

This is a one-day Clery Act Compliance training class that will provide a solid overview of the requirements of the Clery Act and is suited for people who are new to the Clery Act and as well as those who have been practicing practitioners such as Student Conduct and Student Affairs Professionals, Housing Staff (Community Director level and above), Risk Managers, Emergency Managers, Admissions, Human Resources, Athletics, External/Media Relations, College and University Attorneys and others on campus who need to have a solid understanding of the foundations of the Clery Act.



Training will review:

- The general requirements of collecting, classifying, and counting crimes;
- who is and who isn't a campus security authority;
- the responsibilities of those people who are deemed "campus security authorities" according to the law;
- the general requirements of the ongoing disclosures required by the Clery Act, including issuing timely warning notices, immediate (emergency) notifications, and maintaining a daily crime log;
- the required policies and the general requirements surrounding the contents and distribution of the annual security report;
- missing persons, hate crimes, fire safety and emergency response issues; and
- Violence Against Women's Act (SAVE Act) that affect Clery compliance for the institution

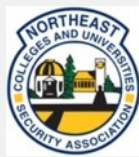
