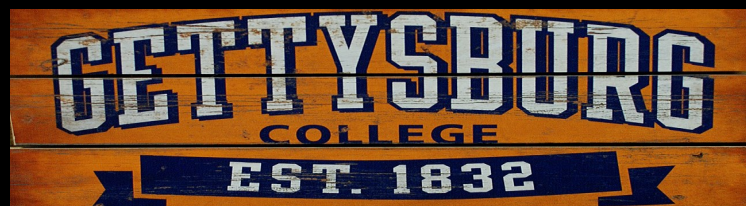
PEER Reviews.....

NECUSA professionals assist colleges and universities in developing and managing security programs and organizational structures meeting industry standards and best practices among peer institutions from within the region. NECUSA has provided peer reviews to schools at the request of newly hired or appointed Chiefs/Directors of Public Safety who were looking for some guidance in determining a solid strategic plan for improvement during their tenure. Other schools have reached out to NECUSA for a peer review as a Chief/Director was leaving or retiring and looking to examine existing organizational structures, policies and protocols as they relate to current standards, model programs and best practices. Other opportunities for a NECUSA review may include addressing changing social climates, significant changes in federal and industry standards and leadership changes at higher levels of the college or university.

A peer review typically consists of three Chief/Director level team members from peer institutions conducting on average a two and a half-day examination of a public safety department's operations, budget, resources, training, compliance efforts, policing philosophies as they relate to the campus climate and culture, emergency operations and preparation, and other areas typically negotiated as part of the planning process. Pricing depends on the size and scope of the peer review. If a member institution is interested in such a service, they should feel free to contact Bill Lafferty, President of NECUSA
